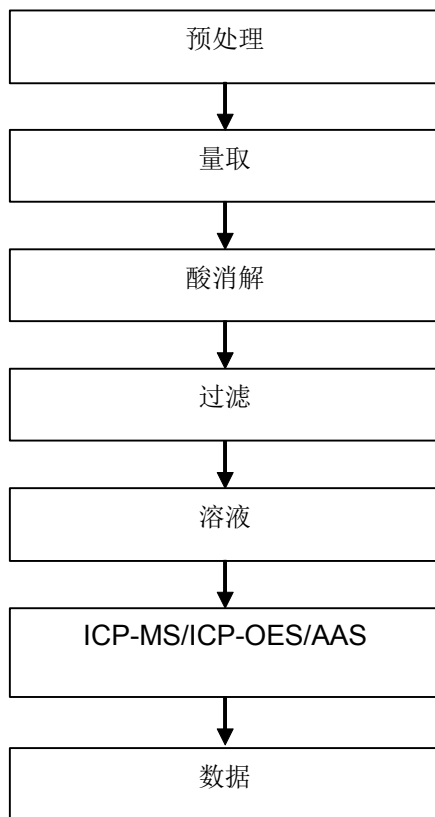

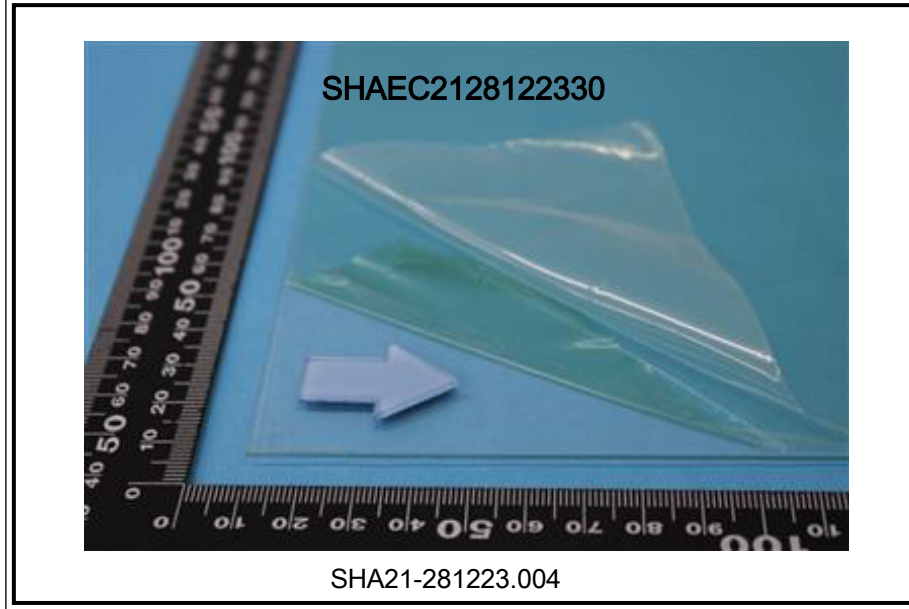
元素测试流程图
