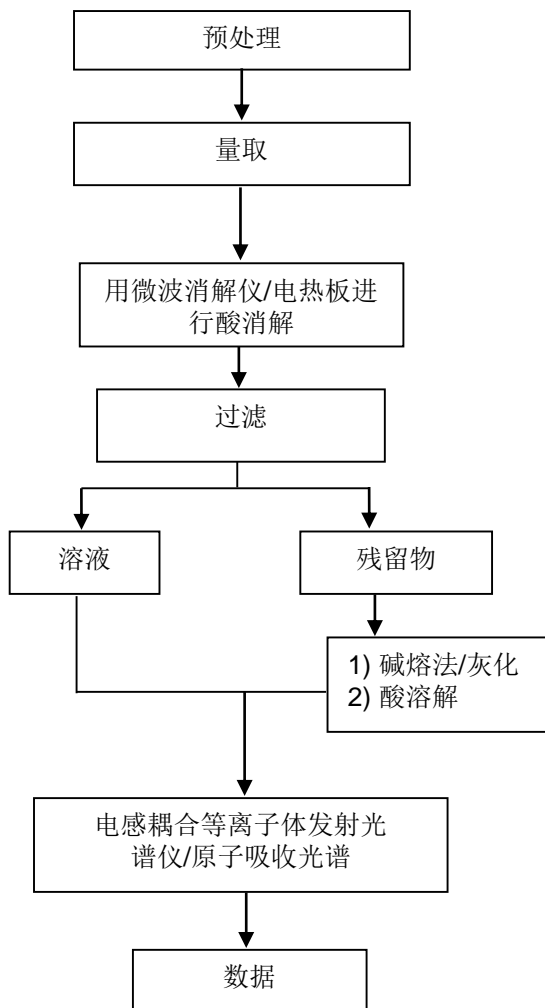

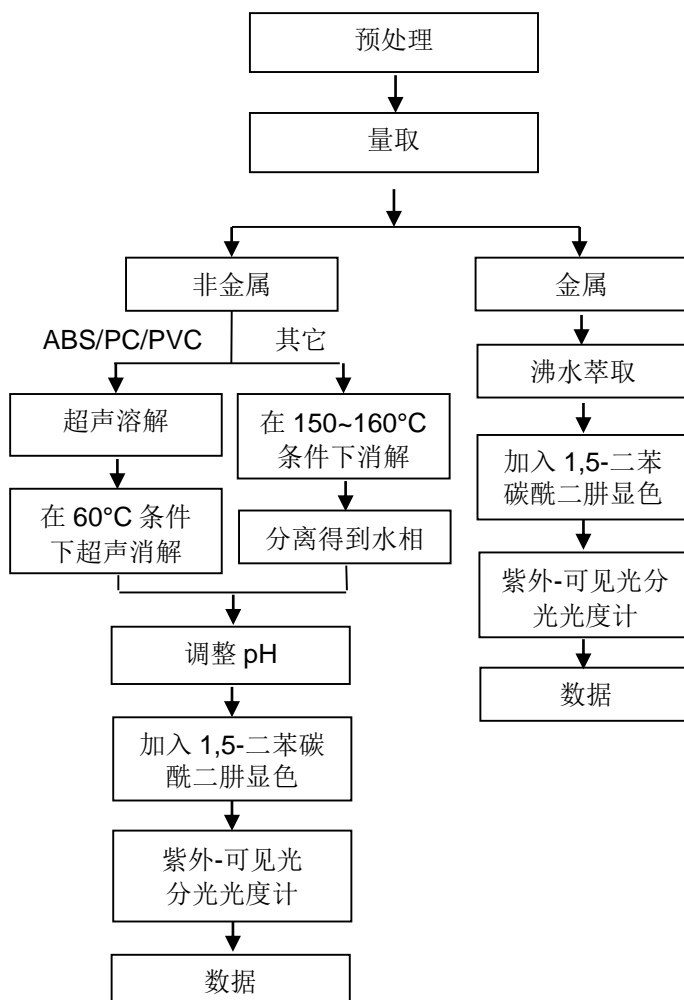

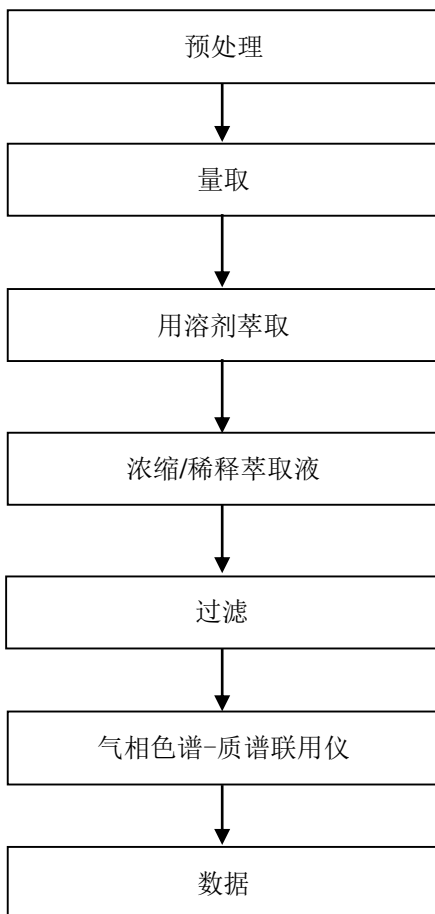

PBBs/PBDEs 检测流程图



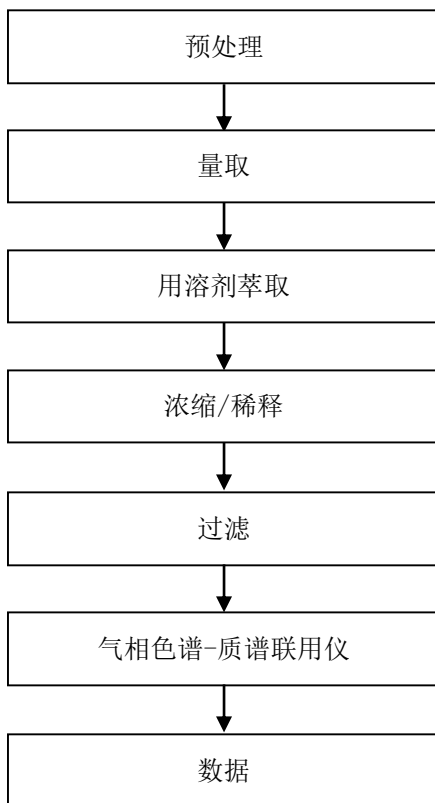

Phthalates 检测流程图



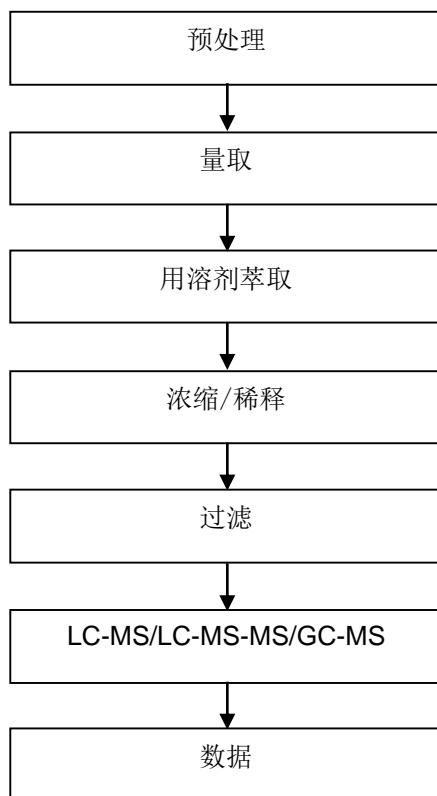

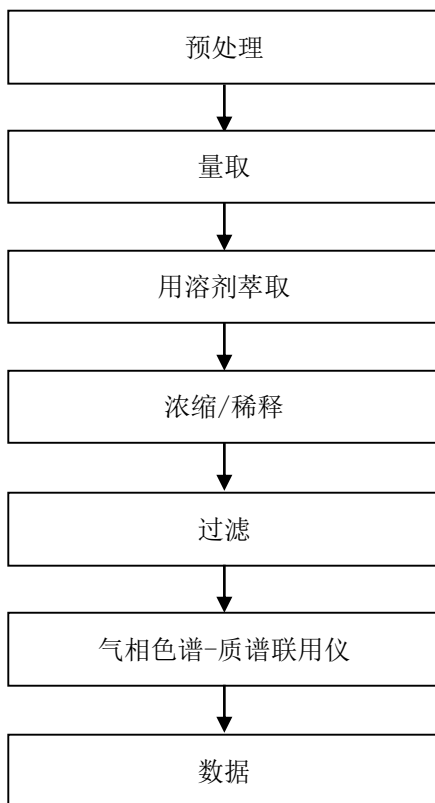

PAHs 检测流程图



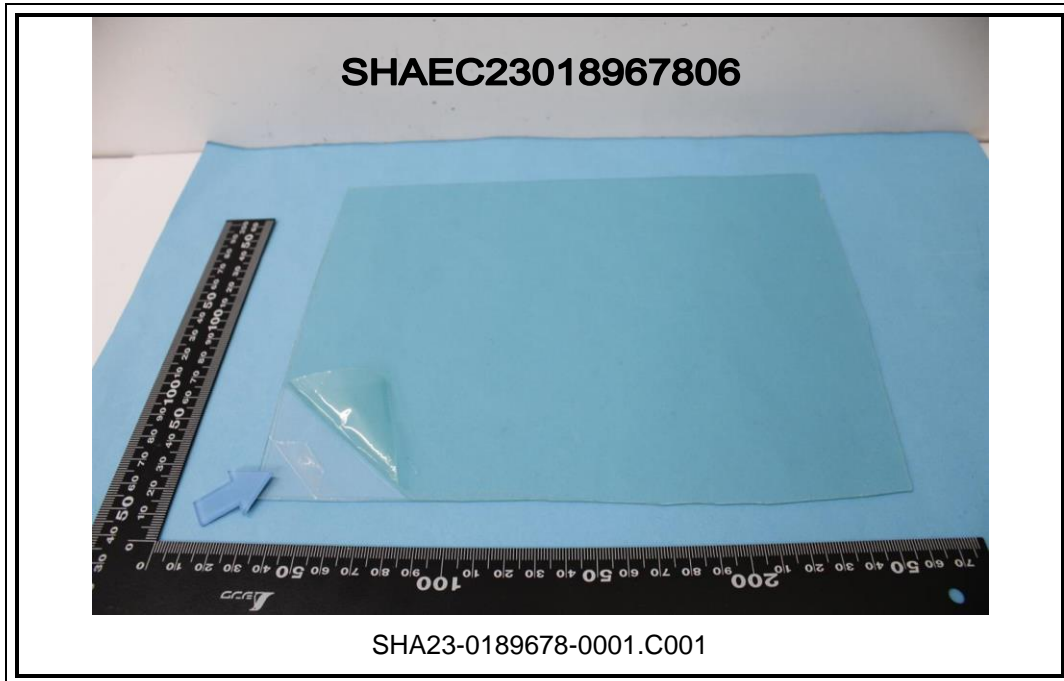
